Board of Scrutiny: Notice of a Bye-election

23 January 2013

The Vice-Chancellor gives notice of an election of a member of the Board of Scrutiny to fill a vacancy in class (c)(ii) following the election of The Reverend J. L. Caddick as a member of the Council from 1 January 2013. The elected member will serve until 30 September 2013. Class (c)(ii) consists of members of the Regent House chosen without limit of age. Under Statute A, VII, 4 no person may be a member of the Board of Scrutiny who is a member of the Council, the General Board, or the Finance Committee of the Council, or who holds any of the University offices of Chancellor, Vice-Chancellor, Pro-Vice-Chancellor, University Advocate, Deputy University Advocate, Registrar, Assistant Registrar, or Secretary of a School. The Ordinances for the Board (*Statutes and Ordinances*, p. 116) further exclude Directors and Deputy Directors in the University Offices (Unified Administrative Service) and Assistant Treasurers.

In order to be eligible, a candidate must be nominated on a paper sent to the Vice-Chancellor at the Old Schools so as to reach him not later than noon on Wednesday, 6 February 2013.

The paper must contain (a) a statement signed by two members of the Regent House, nominating the candidate for election and (b) a statement signed by the candidate certifying that he or she consents to be so nominated. The candidate should also submit a *curriculum vitae* (see below).

The Vice-Chancellor would be obliged if nominations could be delivered to the Registry in the Old Schools during office hours. Envelopes should be clearly marked as Nomination papers. Nomination papers may also be faxed to 01223 332332 or scanned (showing signatures) and sent by email to registry@admin.cam.ac.uk. Nominations will be published as they are received. The complete list of nominations will be published in the *Reporter* on Wednesday, 13 February.

Regulation 3 of the regulations for the election of members of the Council (*Statutes and Ordinances*, p. 114) applies also to the Board of Scrutiny. Under this regulation, each person nominated for election is required to send to the Registry, not later than noon on Wednesday, 6 February, a statement of her or his *curriculum vitae* for distribution to members of the Regent House with the voting papers. It is suggested that such a statement should be of not more than 500 words in length, and that it should cover the following points:

- the candidate's present position in the University;
- previous posts held, whether in Cambridge or in other universities, or outside the university system, with dates;
- a note of the candidate's particular interests within the field of University business.

If more than one nomination is received, voting papers will be distributed, together with the statements provided by candidates, not later than Thursday, 21 February. The last date for the return of voting papers will be 5 p.m. on Thursday, 7 March.

Regulation 2 for the election of members of the Board of Scrutiny (*Statutes and Ordinances*, p. 116) provides that, if at any election insufficient nominations are received to fill the vacant places in either class (c)(i) or class (c)(ii), the Council shall appoint as many members as may be necessary.

Election of student members of the Council and of the General Board: Notice

22 January 2013

Student members of the Council

Notice is given that an election of three students to serve as members of the University Council in accordance with Statute A, IV, 2 (class (d)) will be held from Monday, 4 March to Wednesday, 6 March 2013. Members are to be elected in the following two categories (*Statutes and Ordinances*, p.114):

- (i) two students elected by and from among all eligible students in the University;
- (ii) one graduate student elected by and from among all eligible graduate students in the University.

No person shall be nominated in both categories. Members elected are to serve for one year from 1 July 2013.

Student members of the General Board

Notice is given that an election of two students to serve as members of the General Board in accordance with Statute C, I, 4 (d) will be held on the same days. Members are to be elected in the following two categories (*Statutes and Ordinances*, p.117):

- (i) one undergraduate student elected by and from among all eligible undergraduate students in the University;
- (ii) one graduate student elected by and from among all eligible graduate students in the University.

Members elected are to serve for one year from 1 July 2013.

The elections

In accordance with the Joint Report by the Council and the General Board on student membership of the two bodies, dated 11 and 23 January 2012 (*Reporter*, 6252, 2011–12, p. 405) and the Notice on Student Elections to the Council and the General Board, dated 17 September 2012 (*Reporter*, 6278, 2012–13, p. 2), for the first time this year these electoral processes will be integrated with a wider set of elections to offices in the Cambridge University Students' Union and the Graduate Union. The electoral process is being run by the two Unions and the Vice-Chancellor has appointed Dr Kirsty Allen, Head of the Registry's Office, to act as the University's official Observer with regard to the elections that include membership of the Council and the General Board. Full details of the timetable, nominations process, and eligibility criteria will be published on the Unions' websites (<http://www.cusu.cam.ac.uk/> and <http://www.gradunion.cam.ac.uk/>).

In accordance with Regulation 9 of the regulations for the election of members of the Council in class (d), electoral rolls will be available for inspection in the University Offices Reception, The Old Schools, Trinity Lane, in the week commencing Monday, 4 February 2013.

The Gates Cambridge Trust: Provost

The Gates Cambridge Trust was founded in 2000 from a generous endowment of \$210m from the Bill and Melinda Gates Foundation. The endowment is managed to provide funds in perpetuity for Scholars to be fully-funded for M.Phil. or Ph.D. programmes at Cambridge. To date, the Trust has provided Scholarships to over 1,000 postgraduate Scholars from 95 countries to study at the University since 2001. The original value of the endowment has been preserved and the Trust can look forward to fully-funding Scholars at current levels far into the future. Currently, 90 new Scholars are admitted every year. More information on the Gates Cambridge Trust may be found at <http://www.gatescambridge.org>.

The Trustees are now seeking to appoint a Provost for the Gates Cambridge Trust to succeed Professor Robert Lethbridge when he steps down from that post on 30 September 2013. The Provost is the senior executive for the Trust. Candidates must be well-respected and experienced members of the University or a College who can provide strategic leadership to the Trust, be an ambassador for its Scholars and alumni, and be able to promote the Trust's objects to wider society. The post will be remunerated at 50 per cent of point 83 on the University's pay scales (£100,854, pay award pending) and may be held alongside another University or College office, subject to the necessary permissions. Alternatively, the Trust would be willing to buy-out 50% of the time of the person appointed by compensating her or his Department or College accordingly. The work of the Provost will require flexibility of commitment and a willingness to travel. An appointment will be made for five years.

The Trustees have established an appointment committee for the post, chaired by the Vice-Chancellor. The committee expects to recommend an appointment to the meeting of the Trustees on 31 May 2013. Interviews for the post will be held on 26 March 2013.

General Regulations for the Master of Studies: Correction

(*Statutes and Ordinances*, p. 542)

With effect from 1 October 2012

The Notice published on 5 December 2012 (*Reporter*, 6288, 2012–13, p. 197) announcing amendments to the General Regulations for the Master of Studies did not take account of changes made to the regulations by Grace 3 of 1 February 2012 (*Reporter*, 6253, 2011–12, p. 426). Regulation 15 of the revised regulations should read as follows:

15. If the Tutor of a candidate for the degree supplies the Board of Graduate Studies with satisfactory evidence that the candidate has been hindered by illness or other grave cause in preparing for or taking the examination or any part of the examination for the degree, and such representations are received by the Secretary of the Board not later than three months after the date on which the result of the examination was communicated, the Board shall have power, notwithstanding any provision to the contrary in the relevant regulations,

- either* (a) to approve the candidate for the degree or other qualification without further examination, provided that no candidate shall be so approved unless the Degree Committee concerned judge her or him to have performed with credit in a substantial part of the examination,
- or* (b) to allow the candidate to be examined or re-examined under such conditions and at such time as may be determined by the Board after consultation with the Degree Committee concerned.

Representations received after the prescribed time limit shall not be considered. The Secretary of the Board shall communicate any decision by the Board under this regulation to the Strategic Committee of the Institute of Continuing Education.

A student, or her or his Tutor with the student's consent, may seek review of a decision in relation to that student made by the Board of Graduate Studies. A request for review shall be made in writing, stating the grounds of review, normally within one month of written notification of the Board's decision (unless, in exceptional circumstances, the Registry or a deputy permits a longer period). If the request includes, in the opinion of the Chair of the Board, relevant additional information not previously available, the Board will reconsider its decision at its next meeting following receipt of the request. If no such additional information is included or if, on reconsideration, the decision is reaffirmed by the Board, the procedure described in the following paragraphs shall apply.

The Registry or a deputy shall appoint a reviewer. Exceptionally, a panel of three reviewers may be appointed. If so, references below to 'the reviewer' shall be construed accordingly.

The reviewer will consider the request, the documentation available to the Board (less any confidential medical information), the Ordinances which apply to the Board's decision, and the Board's Notes of Guidance. He or she will obtain an opinion from the Board, seek such other information as he or she may require and, at her or his discretion, may hold a hearing (but there is no obligation to hold a hearing). The reviewer will issue an adjudication in writing as soon as possible, stating findings of fact, conclusions, and, if any, recommendations, for consideration by the Board. The reviewer shall be concerned with determining whether there is evidence of: inadequate consideration of the matter by the Board; the Board having made a decision, to the detriment of the student, which is inconsistent with the relevant Ordinances or its own Notes of Guidance; or material circumstances of which the Board was unaware and which were of such a nature as, had the Board been so aware, to have been likely to cause the Board to have reached a different decision.

The Board shall normally accept the recommendation of the reviewer. If, exceptionally, the reviewer's recommendation is not accepted a written explanation shall be provided to the reviewer, the student, and her or his Tutor. The Board may decide not to accept a recommendation in any instance in which: (i) the reviewer has sought to make a decision replacing that of the Board; (ii) the reviewer's recommendation is inconsistent with the Ordinances governing Allowances; or (iii) the reviewer's recommendation is such that, were it to be accepted, it would set a precedent which would not be in the interests of the proper conduct of the Board's business or in the wider interests of the University.

The conclusion of the consideration by the Board of Graduate Studies of any recommendation by a review shall be the normal final point of decision within the University. A reviewer may summarily dismiss an application which seems to her or him to be vexatious or frivolous.

REPORTS

First-stage Report of the Council on the alteration and refurbishment of the Arup Building on the New Museums Site

The COUNCIL begs leave to report to the University as follows:

1. In this Report the Council is seeking approval in principle for the refurbishment and alteration of the Arup Building on the New Museums Site as set out below.

2. The Arup Building is located on the eastern side of the New Museums Site, adjacent to Corn Exchange Street and between the Department of Zoology Building and the Corn Exchange. It was completed in 1971 to the designs of Sir Philip Dowson of architects Arup Associates. It has an approximate gross internal area of 16,000 m² and a net useable area of approximately 9,200 m² with existing accommodation for the Department of Zoology, the Museum of Zoology, the Department of Materials Science and Metallurgy, the University Computing Service (UCS), the High Performance Computing Service, and the Babbage Lecture Theatre.

3. The Arup Building consists of: a main block, clad in pre-cast concrete, lead and glass; two structurally independent but linked towers, also clad in glass and lead; and a brick-clad annex which is contiguous with the Department of Zoology building. Though well maintained, the building suffers from a number of significant problems typical of buildings of its era and style. These include extremely inefficient energy use, low levels of comfort for users, technical problems with the roof and glazing, and a raised podium which is unattractive, under-used, and difficult to access.

4. The Department of Materials Science and Metallurgy, the current principal occupants of the building, will be moving to the Department's new building on the West Cambridge Site during 2013. The servers of the University Computing Service and the High Performance Computing Service require more appropriate space and will be relocated in 2013 and the UCS will move to be co-located with the Management Information Services Division on the West Cambridge Site. A total of 5,200 m² of net useable area will be relinquished. This provides an opportunity to carry out major improvements and upgrades to the services and fabric of the entire building which will optimize the building as an asset for the future, provide updated accommodation for new and existing uses, and improve the podium and its problematic relationship to the surrounding built context.

5. The space vacated by the Department of Materials Science and Metallurgy, the University Computing Service, and the High Performance Computing Service equipment on the upper floors of the Arup building will be converted to adaptable office accommodation for occupation by the Cambridge Conservation Initiative (CCI). The founder members of the CCI are: the University of Cambridge, Birdlife International, the British Trust for Ornithology, Flora, and Fauna International, the International Union for Conservation of Nature, the Royal Society for the Protection of Birds, the Tropical Biology Association, TRAFFIC, and UNEP World Conservation Monitoring Centre. The members will occupy varying amounts of space, depending on the number of staff they will be locating in the building, and those organizations that are not a part of the University will become tenants.

Approximately three hundred and sixty workstations will be available for tenants initially, though the internal layout will be adaptable for changing patterns of occupation.

6. The current isolation of the raised podium will be addressed by the creation there of a new entrance to the CCI accommodation, a new café, for use by all members of the University and visiting members of the public, linked to a new foyer to the Museum of Zoology. Access will be improved through the simplification of the level changes on the podium by the introduction of new external lifts and by two new external stairs, one that will link the podium with Corn Exchange Street and another that will rise to the podium from near the entrance to the New Museum Site, by the archway leading off of Pembroke Street.

7. The vacated areas in the lower ground floor currently occupied by the Department of Materials Science and Metallurgy will be converted to use as additional stores for the Museum of Zoology and as a Facilities Management base for the whole of the New Museums Site. The new Museum stores will allow controlled public access to a much higher proportion of the collections and free up space in the existing part of the Museum for a new Education Room and a new School Room in support of public education and outreach programmes. The Facilities Management base, which will lead directly off the existing loading bay on Corn Exchange Street, is a part of proposals being developed to control vehicular access to the New Museums Site.

8. The proposals for the work to the Arup Building are being developed so as to make the building as sustainable as possible within the constraints of the existing building and budget. This will be achieved through a bespoke 'sustainability framework' developed by specialist consultants working with Estate Management and the Cambridge Conservation Initiative. Particular efforts are being made to ensure that sustainable design is carried through in a measureable way into sustainable occupancy of the building. The work to the building will significantly improve its energy efficiency and reduce carbon emissions.

9. The Planning and Resources Committee approved the Full Case for the refurbishment of the Arup Building on 13 July 2011. The total cost of the building proposals is currently estimated to be approximately £59.6m including VAT payable at the standard rate of 20% on the whole project. The Finance Division is looking at the amount of VAT that it will be possible to reclaim. Funding will be provided by donations, the Capital Fund, and a Chest loan to be repaid with rental income from the Cambridge Conservation Initiative tenant organizations.

10. Further details relating to the design, maintenance, recurrent costs, and funding arrangements will be brought to future meetings of the Buildings Committee and the Planning and Resources Committee. A Second-stage Report will be published later this year to gain approval for implementation of the project.

11. Drawings of the proposals are displayed for the information of the University in the Schools Arcade; a location plan of the Arup Building is shown below.

12. The Council recommends:

I. That approval in principle be given for the construction works outlined in this Report.

II. That the Director of Estate Management be authorized to apply for detailed planning approval in due course.

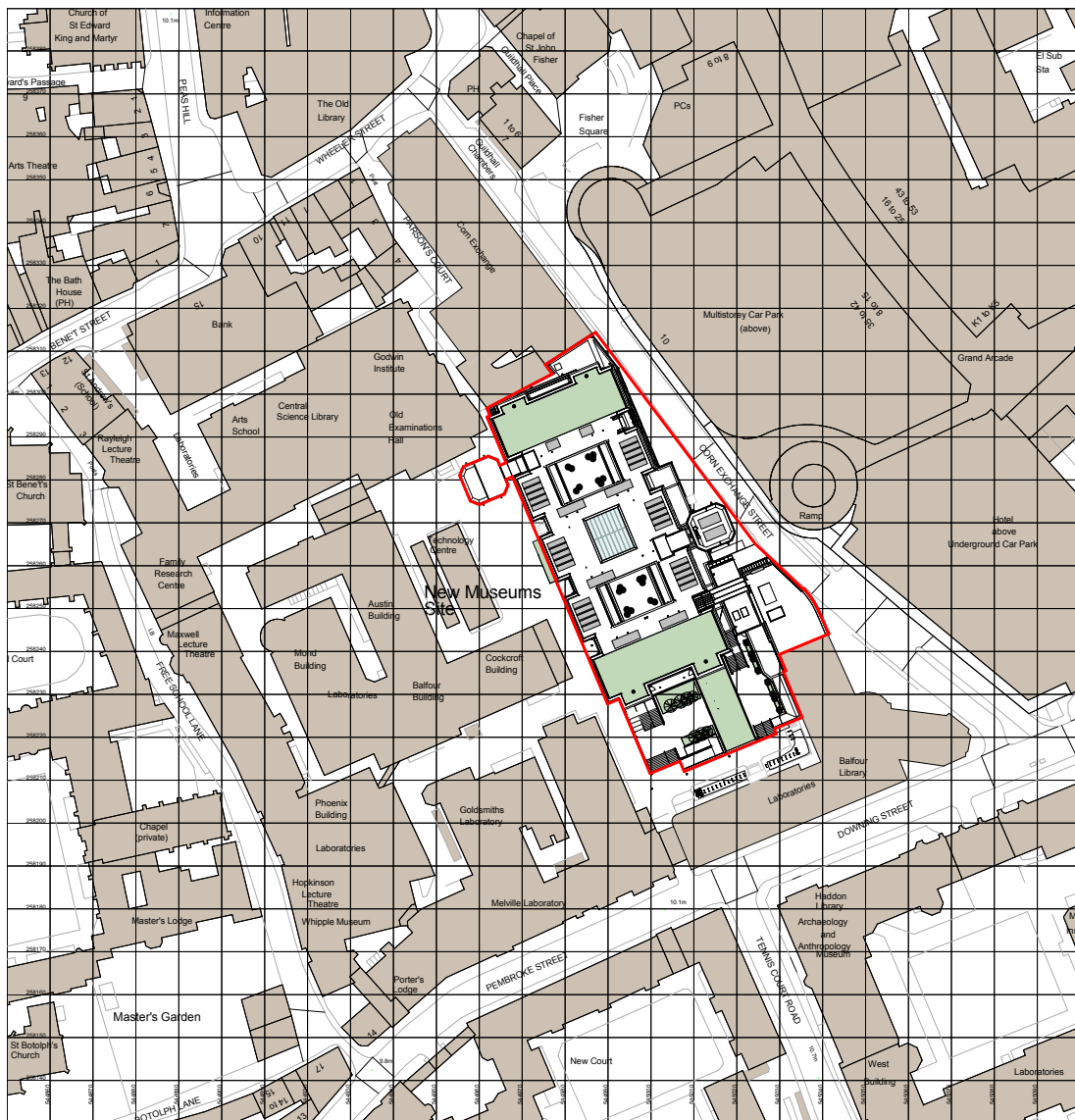

Second-stage Report of the Council on the construction of a new building for the Department of Chemical Engineering and Biotechnology at West Cambridge

The COUNCIL begs leave to report to the University as follows:

1. A First-stage Report on the construction of a new building for the Department of Chemical Engineering and Biotechnology was submitted to the Regent House on 30 June 2012 (*Reporter*, 6273, 2011–12, p. 761) and approved by Grace 2 of 17 October 2012. This Second-stage Report is to update the Regent House on further development of the scheme and to seek approval for construction to proceed.

2. As stated in the First-stage Report the proposed new building for the Department of Chemical Engineering and Biotechnology (CEB) is on the West Cambridge Site between the Institute for Manufacturing and the Department of Materials Science, south of Charles Babbage Road, as shown on the plan below.

3. The new building, which will have a gross internal area of 10,437 m², will provide state of the art facilities for research and teaching in a single location. Considerable efficiency benefits, therefore, are expected. The key aims of the project are:

- to encourage greater interaction and interdisciplinary working;
- to provide facilities in a safe working environment which are better suited to current research;
- to provide flexible space that can be adapted, in the future, as requirements change;
- to create a building that will facilitate teaching, learning, and research in a pleasant environment;

- to create a centre for CEB with a distinctive presence at West Cambridge.

4. The building will include biology, chemistry, and engineering research laboratories which have demanding vibration, acoustic, and electromagnetic environmental needs, in addition to providing for a very extensive teaching programme.

5. In accordance with the Capital Projects Process, a Full Case was prepared by the Department and subsequently approved by the Planning and Resources Committee at their meeting of 4 July 2012. It is estimated that the annual running costs of the new building will be approximately £153 a square metre, (a decrease of £24 a square metre on existing charges) based on the attribution of indirect costs, which cover such items as utilities and maintenance. These costs will be met from funds available to the University.

6. The total cost of the project has been estimated at £60m. Funding of £60m has been confirmed from the Capital Fund, the School of Technology, and the Department of Chemical Engineering and Biotechnology for the purpose of completing the design and construction works. The project cost is based on a start on site in mid-2013 with completion in mid-2015. Planning consent for the construction of the building was granted by the Cambridge City Council on 3 December 2012.

7. Drawings of the proposed scheme are displayed for the information of the University in the Schools Arcade.

8. The Council recommends:

I. That approval is confirmed for the construction of a new building at West Cambridge for the Department of Chemical Engineering and Biotechnology as proposed in this Report.

II. That the Pro-Vice-Chancellor (Planning and Resources) be authorized to accept a tender for the works, within the available funding, in due course.

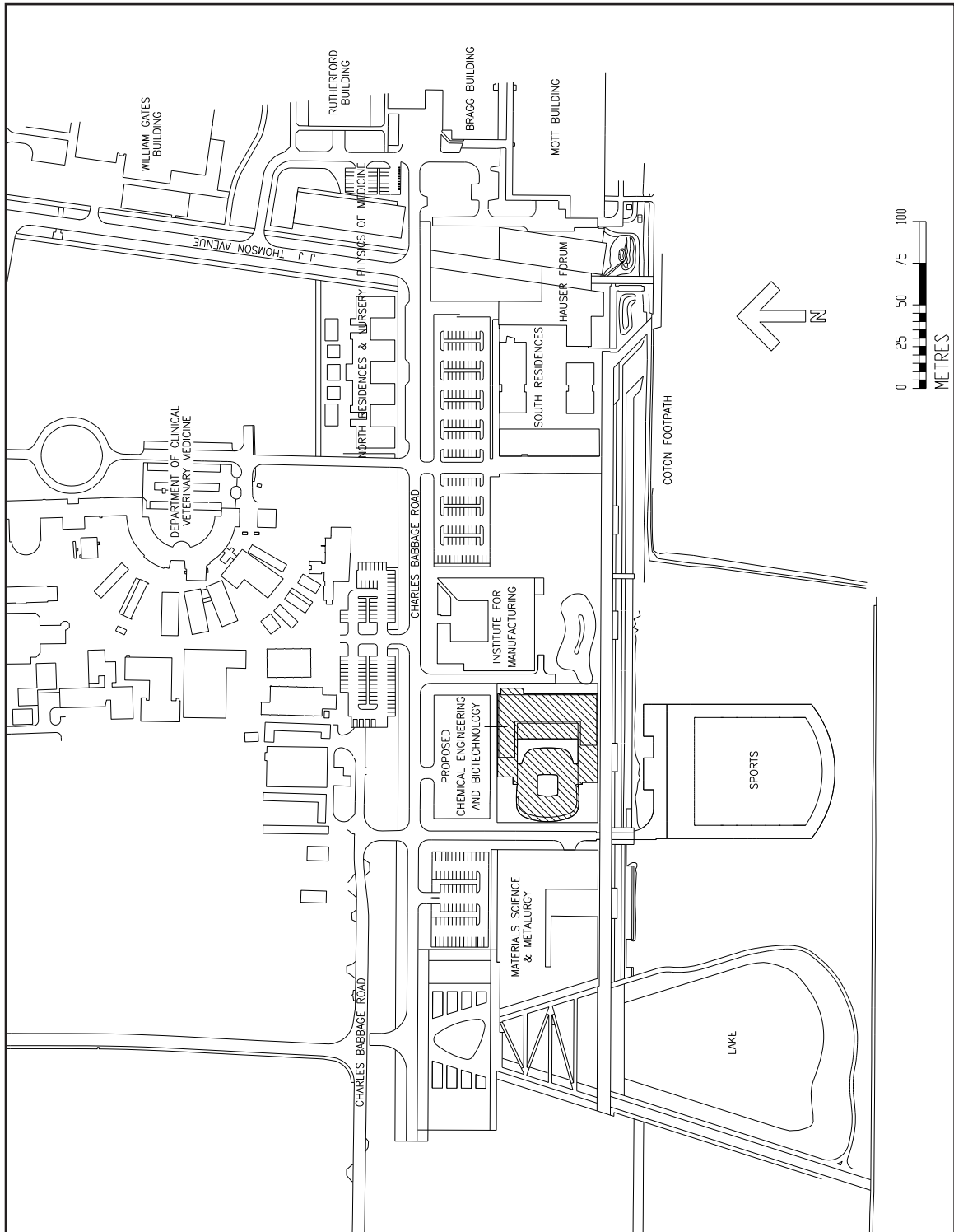
