Office of Pro-Vice-Chancellor (Education)

The Council wishes to make an appointment to the post of Pro-Vice-Chancellor for Education from 1 October 2014, following the retirement from that office of Professor John Rallison on 30 September 2014.

The role of the Pro-Vice-Chancellors is to take forward strategy and policy development and to support the Vice-Chancellor in providing institutional leadership to the University, particularly in their area of responsibility. The Pro-Vice-Chancellors are led as a team by the Senior Pro-Vice-Chancellor, Professor Steve Young. The Pro-Vice-Chancellors work closely with the Heads of Schools and senior professional administrators.

The Pro-Vice-Chancellor (Education) will be appointed by the Council, after consultation with the General Board, for a period of three years from 1 October 2014. The Council will be advised by a Nominating Committee chaired by the Vice-Chancellor and with the following members: Dr David Good, Professor Frank Kelly, and Professor Shirley Pearce (members of the Council) and Professor Martin Daunt and Professor Rob Kennicutt (members of the General Board). The Senior Pro-Vice-Chancellor, Professor Steve Young, attends meetings of the Nominating Committee.

The Pro-Vice-Chancellor will be appointed at 80% of full time on secondment for three years in the first instance. There is the possibility of reappointment to a maximum tenure of six years. The stipend payable is point 87 of the single salary spine, currently £114,629 (as at 1 August 2012), *pro rata*.

The Nominating Committee welcomes expressions of interest by and suggestions of suitable persons who hold a senior post in the University or a College with extensive experience in higher education and a demonstrable interest and current engagement in educational matters within the University or a College.
