# **Humanities and Social Sciences Libraries Sub-syndicate**

#### With immediate effect

The General Board give notice that, on the recommendation of the Library Syndicate and the Council of the School of Humanities and Social Sciences, they have approved the establishment of a Humanities and Social Sciences Libraries Sub-syndicate to oversee affiliated libraries in the Humanities and Social Sciences. The General Board have therefore approved an amendment to the regulations for the Library Syndicate (*Statutes and Ordinances*, p. 656) as set out below.

By inserting new Regulation 10 as follows and renumbering the remaining regulations:

- 10. The Humanities and Social Sciences Libraries Sub-syndicate shall consist of:
- (a) one person appointed by the Library Syndicate;
- (b) one person appointed by each of the Faculty Boards of Economics, Education, and History;
- (c) two persons appointed by the Faculty Board of Human, Social, and Political Science;
- (d) one person appointed by each of the Boards of History and Philosophy of Science and Land Economy;
- (e) not more than two persons co-opted by the Sub-syndicate, provided that it shall not be obligatory to co-opt any person or persons;
- (f) not more than two members of the University in statu pupillari co-opted by the Sub-syndicate.

Members in classes (a)–(d) shall serve for four years from 1 January following their appointment. Members in classes (e) and (f) shall serve until 31 December of the year in which they are co-opted or of the following year, as the Sub-syndicate shall decide at the time of their co-optation, provided that if a member in class (f) ceases to be in statu pupillari he or she shall thereupon cease to be a member in that class.

# **Annual Meetings of the Faculty Boards**

Clinical Medicine

The Chair of the Faculty Board of Clinical Medicine gives notice that the Annual Meeting of the Faculty will be held at 3.45 p.m. on Tuesday, 19 November 2013, in the Committee Room, Level 4, School of Clinical Medicine. #### Divinity
