**General Admission to Degrees, 2017: Notice of procedure**

The Vice-Chancellor gives notice that at the Congregations for General Admission to Degrees to be held on 28, 29, 30 June, and 1 July 2017, tickets will be required for admission to the Senate-House. Admission tickets are issued by Colleges, and prospective graduands should apply to their Colleges for admission tickets for their personal friends whom they wish to invite to the Congregations. Other members of the University who wish to be present are also asked to obtain tickets from their Colleges.

The Congregations will be divided into separate sessions, with intervals between the presentation of candidates from successive Colleges, except that candidates from Murray Edwards College and Darwin College will be presented in a single session, as will candidates from Wolfson College and Clare Hall, and Lucy Cavendish College and St Edmund's College. Visitors may not leave the Senate-House except in the intervals between sessions.

Members of the University are required to wear academical dress in the Senate-House. Any member of the University who is not acting as an officer at the Congregations and who holds a degree of another university or degree-awarding institution may wear the academical dress appropriate to that degree; save that this provision shall not apply to those presenting for, or receiving, degrees. The days of General Admission are 'scarlet' days, and Doctors in the different Faculties are asked to wear their festal gowns.

**General Admission to Degrees, 2017: Acting Registry's Notice**

**Stipends of the holders of clinical academic offices and payment for clinical responsibility**

22 May 2017

Agreement has been reached on the salary arrangements for clinical academic staff with effect from 1 April 2017. Following a recent meeting of the Board of the Universities and Colleges Employers Association, the Clinical Academic Staff Salaries Committee has agreed to translate the award of the Doctors' and Dentists' Review Body into the salaries of clinical academic staff. The increase, from 1 April 2017, is one percent (1%) on the scale points for NHS Consultants and Clinical Lecturers. Non-consolidated payments awarded under the 2016 pay award ceased at March 2017. In addition, a new scale for Clinical Lecturers commencing training from 1 August 2017 has been agreed.

In accordance with the principle that the remuneration of clinical academic staff in Cambridge should be broadly comparable with that of equivalent staff in other UK medical schools, the General Board has agreed to approve revised stipends and scales of stipends for clinical appointments in Cambridge.

The figures currently shown in Schedule II to the regulations for stipends (*Statutes and Ordinances*, p. 669) are replaced with effect from 1 April 2017, and are as follows:

*For Clinical Lecturers on the equivalent of the NHS Specialist Registrar scales (pre-2009)*

Clinical Lecturer £31,931 by ten increments to £55,288

*For Clinical Lecturers on the equivalent of the NHS Specialty Registrar scales (post-2009)*

Clinical Lecturer £32,478 by ten increments to £57,444

The addition of a new scale to Schedule II to the regulations for stipends

*For Clinical Lecturers commencing training from 1 August 2017*

Clinical Lecturer £26,614, £30,805, £36,461, £46,208

The Board has also approved the following basis for calculating rates of payment for clinical responsibility for University officers with honorary NHS contracts as Consultants:

*New (2003) Consultant contract:*

If the integrated job plan and the honorary Consultant contract agreed with the NHS covers not less than ten Programmed Activities a week, the annual pensionable payment for clinical responsibility will amount to the difference between the officer's prime stipend and her or his notional place on the NHS full-time Consultant salary scale.

That scale is:

With effect from 1 April 2017: £76,761, £79,165, £81,568, £83,972, £86,369, £92,078, £97,787, £103,490.

*Pre-2003 Consultant contract:*

If the honorary Consultant contract agreed with the NHS covers not less than six NHS sessions a week, the annual pensionable payment for clinical responsibility will amount to the difference between the officer's prime stipend and her or his notional place on the NHS full-time Consultant salary scale.

That scale is:

With effect from 1 April 2017: £63,733, £68,293, £72,855, £77,415, £82,616.

The offices of Clinical Sub-Dean in the Faculty of Clinical Medicine, Director and Assistant Director of Studies in General Practice are part-time and stipends are determined by local agreement, with reference to the appropriate full-time Consultant salary.

## Law Tripos

(*Statutes and Ordinances*, p. 358)

### With effect from 1 October 2017

The General Board, on the recommendation of the Faculty Board of Law, has approved amendments to the regulations so as to remove a provision which allowed students to apply to the Faculty Board for an extension to the word limit of their dissertation, to create a Full Paper on Human Rights Law, and to include in the regulations provision for the recognition of Examinations for Professional Exemption.

By adding the following as **new Regulations 2 and 14** and renumbering all subsequent regulations accordingly:

**2.** The Faculty Board, after consulting the professional and other bodies concerned, shall have power to determine the subjects and/or papers for examination or parts thereof that shall be designated by supplementary regulation as Examinations for Professional Exemption.

**14.** A student who fails to take or is unsuccessful in the examination in any subject or paper designated as an Examination for Professional Exemption in accordance with Regulation 2 shall be eligible for re-examination. Subject to Regulation 23, no student shall be a candidate in any Examination for Professional Exemption on more than two occasions in total.

By amending existing **Regulation 14** (to be renumbered Regulation 16) so that it reads:

**16.** There shall be a separate class-list for each Part of the Tripos. In each list the names of the successful candidates shall be arranged in three classes, of which the second shall be divided into two divisions. The names in the first and third classes, and in each division of the second class, shall be arranged in alphabetical order. In each class-list a mark of distinction shall be affixed to the names of those candidates placed in the first class whose work is of special merit. In the class-list for Part II the symbol (*e*) shall be placed against the names of those candidates who have taken the examination under Regulation 6(*a*). Successful candidates in the Examinations for Professional Exemption shall be informed by the Academic Secretary of the Faculty of Law after results are confirmed by the Faculty Board.

By inserting 'Paper 39. Human Rights Law' in existing **Regulation 15** (to be renumbered Regulation 17) under Group III.

By deleting the clause 'to assess that paper' from the first sentence of the existing **Regulation 19** (to be renumbered Regulation 21) so as to read:

A candidate who under Regulation 19 chooses Paper 50 (seminar course) shall be assessed by the Assessors appointed by the Faculty Board.

By amending sub-paragraph (*b*) of the current **Regulation 19** (to be renumbered Regulation 21) so that it reads:

(*b*) The topic of a dissertation on a prescribed subject shall be approved by a lecturer conducting a seminar course (Paper 50). A dissertation shall not exceed 12,000 words including footnotes and appendices, but excluding bibliography. Candidates shall be required to state in a preface that the dissertation represents their own work unaided except as may be specified in the declaration. Dissertations shall be sent to the Secretary of the Faculty Board so as to arrive not later than the seventh day of Full Easter Term in the year in which the examination is to be held. A candidate who submits a dissertation after this date may be penalized. The dissertation shall be computer-written.

By adding the following paragraph as **new Regulation 23**:

The Faculty Board of Law shall establish a procedure for the review of the Board's decisions in respect of students who have applied exceptionally for an additional attempt at an examination designated as an Examination for Professional Exemption under Regulation 14. No person who applies for review under the procedure so established shall be entitled to apply also for review of the same matter under the procedure for determining complaints by members of the University *in statu pupillari* established under the Regulation for complaints by students.

The Faculty Board of Earth Sciences and Geography gives notice that, for the examination for Part IB and Part II of the Geographical Tripos to be held in 2018, the papers to be offered will be examined as shown in the tables below. In these tables, the following terms are defined:

1. 'Two+1 examination': The assessment of such papers will consist of a conventional two-hour examination in which candidates will be asked to attempt two questions from a choice of not fewer than six questions. The papers will be undivided. In addition, there will be assessed coursework to be submitted not later than the division of the Easter Term in the year of the examination. The nature of the coursework required will be determined by the University Teaching Officer responsible for the co-ordination of the course, who will provide written details of the procedures which will be followed. The coursework will be equivalent to one question in quantity and for assessment in determining an overall mark for the paper.
2. 'Three-hour examination': The papers will be examined by a conventional unseen three-hour examination in which candidates will be asked to attempt three questions from a choice of not fewer than nine questions. The papers will be undivided.

**REPORTS****Report of the Council on the provisions concerning the initiation of Graces and of amendments to submitted Graces by members of the Regent House**

The COUNCIL begs leave to report to the University as follows:

1. This Report proposes that a new provision is inserted in Statute A III to affirm that the Regent House has authority to initiate a Grace or to propose an amendment to a submitted Grace.

2. Following a technical review of the University's Statutes completed in 2012–13, the Council proposed that certain provisions previously set out in Statute should be transferred to Special Ordinance. These proposals were approved by Grace 2 of 3 July 2013, and revised Statutes and new Special Ordinances came into force on 11 February 2014 (*Reporter*, 6338, 2013–14, p. 371).

3. One of the changes which took effect on 11 February 2014 was the removal of Sections 7–9 from Statute A VIII

and their relocation as Sections 5–7 in Special Ordinance A (i). These provisions concern the initiation of a Grace or a proposal for the amendment of a submitted Grace by members of the Regent House. The Council is of the view that the powers of members of the Regent House to initiate and submit Graces to the Regent House, and to initiate proposals for the amendment of a Grace already submitted to the Regent House but not yet approved, were not affected by the relocation, but it is nevertheless considered that for the avoidance of doubt it would be prudent to affirm these powers by inserting a new provision in Statute and amending the wording of Statute A VIII (c).

4. The Council recommends that, subject to the approval of Her Majesty in Council, the Statutes of the University be amended as set out below and that these amendments be submitted under the Common Seal of the University to Her Majesty in Council for approval.

(a) That new Section 4 below be inserted in Statute A III (*Statutes and Ordinances*, p. 5) and the remaining Sections 4–10 renumbered as 5–11:

4. The Regent House shall have the power of initiating Graces to the Regent House and of initiating proposals for the amendment of a Grace already submitted to the Regent House but not yet approved, as prescribed by Special Ordinance.

(b) That the final sentence of Statute A VIII (c) (*Statutes and Ordinances*, p. 10) be amended so as to read:

All Graces submitted require the authorization of the Council; the Council may withhold that authorization in circumstances as prescribed by Special Ordinance;
