Redevelopment of the Old Press / Mill Lane site

7 March 2018

The Council wishes to inform the University of forthcoming consultations concerning the Old Press / Mill Lane site.

Consultation on the development of the site

A master plan for the Old Press / Mill Lane site is being developed by the University and several Colleges interested in developing a substantial part of the site for graduate student accommodation. The emerging master plan was presented to the Estates Strategy Committee at a meeting on 10 January 2018, and endorsed as the basis for consultation with the public and other key stakeholders. Public exhibitions will be held in the University Centre on 22 and 23 March 2018, and will be supplemented by meetings with members and officers of Cambridge City Council and other local and regional politicians, and with environmental, transport, and architectural heritage groups, and community organizations. The master plan for Old Press / Mill Lane is expected to be finalized during 2018, subject to the necessary University and College approvals. The University has already approved, by Grace 1 of 19 July 2017, the grant to Pembroke College of a long lease for Kenmare House, Stuart House, and 4 Mill Lane. Regent House approval will be sought for further divestment of land or buildings, and for the construction or demolition of individual University buildings and additional works within the site.

Consultation on the University Centre

The University Centre is a key part of the Old Press / Mill Lane site. The Centre is home to a café, restaurant, wine bar, and dining hall, and is currently used for a variety of formal and informal uses by the University and its alumni, as well as external users, with around 390,000 visitors a year.

As part of the proposed development of Old Press / Mill Lane, the University wishes to understand how the Centre is currently used and what the best future uses might be.

As a first step in this process, a survey will be undertaken to gain a full picture of who currently uses the University Centre, why and how often, what is important to them, and also the services they think the University needs to offer in the future. REGULATIONS FOR EXAMINATIONS**Examination in Earth Sciences for the M.A.St. Degree***(Statutes and Ordinances, p. 446)***With effect from 1 October 2019**

The General Board, on the recommendation of the Degree Committee for the Faculty of Earth Sciences and Geography, has approved the introduction of the examination in Earth Sciences for the degree of Master of Advanced Study. Special regulations for the examination have been approved as follows:

EARTH SCIENCES

The examination in Earth Sciences for the M.A.St. Degree shall comprise the examination requirements as set out in the regulations for the subject Earth Sciences in Part III of the Natural Sciences Tripos. The conduct of the examination shall be governed for the regulations for that part, provided that a candidate shall be a candidate not for honours and the candidate's name shall not appear in the class-list for the Tripos. Distinctive marks may be attached to the names of those candidates who in the opinion of the Examiners deserve special credit: the mark (*d*) being used to denote a distinguished performance and the mark (*c*) a commendable performance.
