# Natural Sciences Tripos, Part II (Biological and Biomedical Sciences), 2019–20

The Faculty Board of Biology gives notice, in accordance with Regulation 30 for the Natural Sciences Tripos, that the following combinations of Major and Minor Subjects will be offered in the Natural Sciences Tripos, Part II (Biological and Biomedical Sciences) in 2019–20.
