## Report of the Council on recognition of the merger of Cambridge University Press and Cambridge Assessment in the University's Statutes and Ordinances: Corrections

10 March 2021

In Annex C to the above Report (*Reporter*, 6608, 2020–21, p. 380), there are two errors in the proposed Ordinance for the Press and Assessment Syndicate. The following corrections have been made:

Annex C, sub-paragraph (f):

- in Regulation 3(f), by replacing the reference to the Press Seal with a reference to the Press and Assessment Seal;
- in Regulation 7, by replacing the reference to the Press Syndicate with a reference to the Press and Assessment Syndicate.

## Grace 1 of 17 February 2021 (establishment of an Endowment Fund Supervisory Body): Legal advice and revised ballot timetable

11 March 2021

Further to the Notice of a ballot dated 26 February 2021 (*Reporter*, 6609, 2020–21, p. 394), the Council has taken the decision exceptionally to waive privilege in the written legal advice of 13 February 2019, which underlies the recommendations in its Report of 14 December 2020 (*Reporter*, 6601, 2020–21, p. 259). The recommendations, most unusually, affect the position of the Council in relation to other bodies in the University's governance structure; they also impact the interests of third party investors in addition to those of the University. For these two reasons, the Council has concluded that the advice should be available beyond the members of the Council to the wider University and therefore the Council has chosen, in this instance, to waive privilege. The advice also provides further information on the changes needed to comply with applicable legal and regulatory requirements. It should be noted that the waiver of legal privilege in this case is limited to the written advice as described above and does not constitute a waiver of privilege in relation to any other legal advice, which the Council may have received, or may receive in the future. ## REGULATIONS FOR EXAMINATIONS

### Master of Law (LL.M.)

*(Statutes and Ordinances, p. 473)*

#### With effect from January 2021

The General Board, on the recommendation of the Faculty Board of Law, have approved an amendment to the regulations for the LL.M. Examination so as to allow the Faculty Board of Law to approve no less than four subjects that fall within one or more of the following fields: Commercial Law, European law, Intellectual property, International law. The opportunity has also been taken to replace the term ‘thesis’ with ‘dissertation’ throughout the regulations, in line with current policy.

By amending Regulation 1 to read as follows:

1. The LL.M. Examination shall comprise not more than thirty-five subjects, prescribed by the Faculty Board of Law, which may include a seminar paper to be assessed by dissertation only. Subject to approval by the Faculty Board of Law at its January meeting each year, the list of subjects may include not less than four subjects that fall within one or more of the following fields:

- Commercial law
- European law
- Intellectual property
- International law.

And by replacing the word ‘thesis’ with ‘dissertation’ throughout the regulations.

### English Studies for the M.Phil. Degree by advanced study

*(Statutes and Ordinances, p. 528)*

#### With effect from 1 October 2021

The General Board, on the recommendation of the Faculty Board of English, has approved amendments to the scheme of examination in English Studies for the degree of Master of Philosophy, as part of the implementation of a new course of study in this subject. Regulation 1(b) of the special regulations for the examination has been revised as follows:

- (b) *either two essays, or one essay and one examined exercise in medieval textual and related studies, each essay to be of not less than 4,500 and not more than 5,000 words in length and on a topic approved by the Degree Committee.*

### Epidemiology for the M.Phil. Degree by advanced study

*(Statutes and Ordinances, p. 529)*

#### With effect from 1 October 2021

The General Board, on the recommendation of the Faculty Board of Clinical Medicine, has agreed to withdraw the examination in Epidemiology for the degree of Master of Philosophy by advanced study and for the special regulations for that examination to be rescinded.

## Population Health Sciences for the M.Phil. Degree by advanced study

### With effect from 1 October 2021

The General Board, on the recommendation of the Faculty Board of Clinical Medicine, has approved Population Health Sciences as a subject for examination for the degree of Master of Philosophy by advanced study. Special regulations for the examination in the subject have been approved as follows:

#### POPULATION HEALTH SCIENCES

1. The scheme of examination for the course of study in Population Health Sciences for the degree of Master of Philosophy shall consist of:
  - (a) a dissertation, of not more than 15,000 words in length, including footnotes, but excluding tables, appendices, and bibliography, on a subject approved by the Degree Committee for the Faculties of Clinical Medicine and Veterinary Medicine;
  - (b) five assignments relating to core modules prescribed by the Degree Committee;
  - (c) six assignments relating to optional modules published by the Degree Committee.
2. Assignments relating to modules shall take the form of written exercises of not more than 1,500 words each, or of alternative equivalent exercises specified by the Degree Committee.
3. The examination shall include an oral examination on the dissertation and on the general field of knowledge within which it falls and on the other work submitted by the candidate; save that the Examiners may, at their discretion, waive the requirement for an oral examination.
4. Any candidate may choose to pursue one of the thematic pathways of optional modules as specified from time to time by the General Board on the recommendation of the Degree Committee.

## Primary Care Research for the M.Phil. Degree by advanced study

*(Statutes and Ordinances, p. 542)*

### With effect from 1 October 2021

The General Board, on the recommendation of the Faculty Board of Clinical Medicine, has agreed to withdraw the examination in Primary Care Research for the degree of Master of Philosophy by advanced study and for the special regulations for that examination to be rescinded.

## Public Health for the M.Phil. Degree by advanced study

*(Statutes and Ordinances, p. 543)*

### With effect from 1 October 2021

The General Board, on the recommendation of the Faculty Board of Clinical Medicine, has agreed to withdraw the examination in Public Health for the degree of Master of Philosophy by advanced study and for the special regulations for that examination to be rescinded.

## Population Health Sciences for the M.St. Degree

### With effect from 1 October 2021

The General Board, on the recommendation of the Faculty Board of Clinical Medicine, has approved Population Health Sciences as a subject for examination for the degree of Master of Studies. Special regulations for the examination in the subject have been approved as follows:

#### POPULATION HEALTH SCIENCES

1. The scheme of examination for the two-year course of study in Population Health Sciences for the degree of Master of Studies shall consist of:
  - (a) a dissertation, of not more than 15,000 words in length, including footnotes, but excluding tables, appendices, and bibliography, on a subject approved by the Degree Committee for the Faculties of Clinical Medicine and Veterinary Medicine;
  - (b) five assignments relating to core modules prescribed by the Degree Committee;
  - (c) six assignments relating to optional modules published by the Degree Committee.
2. Assignments relating to modules shall take the form of written exercises of not more than 1,500 words each, or of alternative equivalent exercises specified by the Degree Committee.

3. The examination shall include an oral examination on the dissertation and on the general field of knowledge within which it falls and on the other work submitted by the candidate; save that the Examiners may, at their discretion, waive the requirement for an oral examination.

4. Any candidate may choose to pursue one of the thematic pathways of optional modules as specified from time to time by the General Board on the recommendation of the Degree Committee.

5. The Examiners may recommend to the Degree Committee that it awards the Postgraduate Diploma to a candidate who has satisfactorily completed the assessments specified in Regulation 1(b) and 1(c), but who has not completed, or has failed to reach the required standard in, the dissertation under Regulation 1(a).

6. The Examiners may recommend to the Degree Committee that it awards the Postgraduate Certificate to a candidate who has satisfactorily completed the assessments specified in Regulation 1(b), but who has not completed, or has failed to reach the required standard in, the assessments specified in Regulation 1(c).

## NOTICES BY FACULTY BOARDS, ETC.

### Medical Sciences Tripos, Part Ib, 2020–21

The Faculty Board of Biology and the Faculty Board of Clinical Medicine give notice that, with effect from the examinations to be held in 2021, the form of examination for *Biology of Disease* for Part Ib of the Medical Sciences Tripos will be changed as follows:

#### *Biology of Disease (BOD)*

- (i) Section I and Section III will be sat as separate examination papers. Section I shall be a written paper of 90 minutes duration, containing compulsory short-answer questions. Section III shall be a written paper of two hours duration, containing essay questions.
- (ii) Section I will change from 60 minutes to be 90 minutes in length.

### Natural Sciences Tripos, Part Ib (Experimental Psychology), 2020–21

The Faculty Board of Biology gives notice that with effect from the examinations to be held in 2021 the form of the examination in Experimental Psychology for Part Ib of the Natural Sciences Tripos will be as follows:

#### *Paper 1*

The examination will consist of a three-hour written paper, comprising three sections: Section A, Section B, and Section C. Within each Section candidates should provide TWO short accounts and ONE essay. Each short account carries one-sixth of the available marks, and the essay two-thirds of the available marks.

#### *Paper 2*

The examination will consist of a three-hour written paper, comprising three sections: Section A, Section B, and Section C. Within each Section candidates should provide TWO short accounts and ONE essay. Each short account carries one-sixth of the available marks, and the essay two-thirds of the available marks.

#### *Written practical reports*

Candidates will submit a range of practical reports throughout the academic year, full details of which are provided in the General Guidelines and Arrangements for Written Reports. Reports will be assessed as pass or failure, with one further attempt permitted should the initial report be deemed unsatisfactory. If the revised report is also unsatisfactory, a penalty of 1.5% will be deducted from the final overall mark for the course. Reports that are not submitted will incur a penalty of 1.5% from the final overall mark for the course.

## Natural Sciences Tripos, Part Ib (Plant and Microbial Sciences), 2020–21

The Faculty Board of Biology gives notice that, with effect from the examinations to be held in 2020–21, the form of the examination in Plant and Microbial Sciences for Part Ib of the Natural Sciences Tripos will be as follows:

### *Paper 1 – three hours.*

- *Section A.* Candidates will attempt a choice of eight out of ten short-answer questions offered on the lecture course.
- *Section B.* Candidates will attempt six short-answer questions offered on the practical element of the course.
- *Section C.* Candidates will attempt one long-answer question on topics from the practical element of the course to assess their data handling and scientific reasoning abilities.

### *Paper 2 – three hours.*

Candidates should attempt three Section A and B questions, with at least one question from each of Sections A and B. Candidates should attempt one question from Section C.

- *Section A.* Essay questions on Michaelmas Term lectures set by individual lecturers. Four questions offered.
- *Section B.* Essay questions on Lent Term plus remaining Easter Term lectures set by individual lecturers. Five questions offered. At least one must represent Easter Term lecture material.
- *Section C.* Synoptic essay questions set by more than one lecturer in the course to test candidates' abilities to integrate more than one of the lecture blocks. Four questions offered.

## Psychological and Behavioural Sciences Tripos, Part IA, 2020–21

The Faculty Board of Biology gives notice that, with effect from the examinations to be held in 2021, the form of examination for papers *PBS 1: Introduction to Psychology* and *PBS 2: Psychological enquiry and methods* for Part IA of the Psychological and Behavioural Sciences Tripos has been changed as follows:

### *PBS 1: Introduction to psychology*

The examination will consist of a three-hour written paper containing two sections: Section A and Section B. Candidates must answer three questions from Section A and one question from Section B.

### *PBS 2: Psychological enquiry and methods*

The examination will consist of a three-hour written paper containing four sections: Section A – short answer questions on material taught throughout the course but mainly material from the Michaelmas Term; Section B – short answer questions assessing the ability to apply taught material on statistics; Section C – one 30-minute essay on *either* experimental design *or* a critique of a research study; and Section D – one 30-minute essay on conceptual issues in psychological research.

In addition, students will complete a written report on the analysis and summary of a dataset. A choice of three datasets will be available, across different domains of psychological research, with a submission deadline at the start of Easter Term. Reports will be assessed as pass or failure, with one further attempt should the initial report be deemed unsatisfactory. If the revised report is also unsatisfactory, a penalty of 1.5% will be deducted from the final overall mark for PBS 2.

## Veterinary Sciences Tripos, Part Ib, 2020–21

The Faculty Board of Biology and the Faculty Board of Veterinary Medicine give notice that, with effect from the examinations to be held in 2021, the form of examination for *Biology of Disease* for Part Ib of the Veterinary Sciences Tripos will be changed as follows:

### *Biology of Disease (BOD)*

- (i) Section I and Section III will be sat as separate examination papers. Section I shall be a written paper of 90 minutes duration, containing compulsory short-answer questions. Section III shall be a written paper of two hours duration, containing essay questions.
- (ii) Section I will change from 60 minutes to be 90 minutes in length.



## Master of Corporate Law (M.C.L.), 2020–21

The Faculty Board of Law gives notice that, with effect from the examinations to be held in 2020–21, the form and/or conduct of the examination for the following papers for the degree of Master of Corporate Law (M.C.L.) will be changed as follows:

*Paper M1. The legal and economic structure of corporate transactions (Deals)*

This paper will be evaluated by way of a single piece of coursework assigned during the academic year (the ‘Deals Report’) and on the basis of student presentations. There will be no written examination. The maximum word limit for the Deals Report is 12,000 words.

*Paper M2I. Law and the digital economy*

This paper will contain no fewer than four questions of which candidates will be required to attempt any three.

**The conduct for all papers has been changed to the following:**

*Permitted materials*

The Faculty Board of Law gives notice of the statutes and other materials that M.C.L. candidates may use in Examinations in 2020–21. There are no restrictions on referring during the assessment to books and other materials, whether on paper, online, or in computer files.

*Word limits*

The following word limit applies to all M.C.L. examinations: 4,000 per examination paper.

The word limit for the coursework in Paper M1 (‘Deals Report’) is 12,000 words.

If the applicable word limit is exceeded, Examiners will stop reading at the point at which the word limit is reached.

All other parts of the examination remain unchanged.
