NOTICES BY THE GENERAL BOARD

Payments to Examiners, Assessors and Supervisors who are not medically qualified

31 May 2022

In December 2021, the General Board approved a number of payment rates for Examiners, Assessors and Supervisors who are not medically qualified (*Reporter*, 6640, 2021–22, p. 164). The General Board has subsequently approved an increase to the payment rate for Assessors of first-year doctoral students (progress examination) from a fee equivalent to two hours to a fee equivalent to three-and-a-half hours. This change shall take effect as the payment rate for all such first-year assessments currently taking place. The Schedule attached to the Ordinance on Payments to Examiners, Assessors and Supervisors (*Statutes and Ordinances*, p. 260, as amended by Grace 5 of 8 December 2021) has been amended accordingly.

REGULATIONS FOR EXAMINATIONS

Modern and Medieval Languages Tripos

(Statutes and Ordinances, p. 400)

With effect from 1 October 2023

The General Board, on the recommendation of the Faculty Board of Modern and Medieval Languages and Linguistics, has approved the following amendments to the regulations for the Modern and Medieval Languages Tripos to add Ukrainian as a Tripos language at Part II:

Regulation 18.

By adding the following sentence to the end of sub-paragraph (*a*):

The Faculty Board has agreed that Ukrainian shall constitute a language as specified in Schedule A at Part II only.

Regulation 24.

By replacing the penultimate sentence of sub-paragraphs (a)(i), (b)(i) and (c)(i) with the following:

The Faculty Board has agreed that, for the purposes of this regulation, Paper Pg.3 shall constitute a language paper and Paper Sl.9 shall constitute a language paper as listed in Schedule A.

Chemical Engineering Tripos, Part IIB, 2022–23

The Chemical Engineering and Biotechnology Syndicate gives notice that the modules available for study in Part IIB of the Chemical Engineering Tripos in the 2022–23 academic year will be as follows:

Topics in Group A and Group D are compulsory for all candidates. The regulations specify that each candidate takes a total of six modules from Groups B and C. The Chemical Engineering and Biotechnology Syndicate imposes the restriction that at least two of these modules should be chosen from Group B, and at least two should be chosen from Group C. Further, at least two of the six modules chosen from Groups B and C should be assessed principally or entirely by written examination.
