**NOTICES BY THE GENERAL BOARD****Establishment of a Professorship of Sustainability**

On the occasion of the coronation of King Charles III, the General Board is proposing the establishment of a Professorship of Sustainability in perpetuity from 8 May 2023 (or such later date as the General Board shall determine). The funding arrangements for the Professorship were approved by the Chair of the Resource Management Committee, on behalf of the Committee, on 31 March 2023. The cost of the Professorship will be underwritten by Trinity College and the officeholder will be offered a Fellowship in the College.

The Professorship of Sustainability will be expected to provide a focus for leadership in the field of sustainability research and education across the University. The officeholder will build on the range of existing activity spread across multiple academic Departments and Faculties, to enhance the University's impact in this area.

As a consequence of the interdisciplinary nature of the Professorship, it will be assigned initially to the School of the Physical Sciences and appropriate reassignment to a Department or Faculty will be made by Grace following appointment and subject to approval by the relevant School Council. The officeholder will however be expected to work across all Schools given the multi-disciplinary nature of the subject area of the Professorship.

The General Board has agreed that an election should be made by an *ad hoc* Board of Electors and that the candidature should be open without limitation or preference to all persons whose work falls within the general field of the title of the office.

The Council is submitting a Grace (Grace 3, p. 608) for the establishment of the Professorship.

**Changes to governance arrangements for the Postgraduate Committee****With effect from 1 April 2023**

The General Board has agreed a change to the governance arrangements for the Postgraduate Committee. Under the current arrangements the Postgraduate Committee reports directly to the General Board. The Board has approved a change in arrangements to place the Postgraduate Committee formally under the General Board through its Education Committee, as a sub-committee of the General Board's Education Committee.

## REPORTS

### Report of the Council on corrections and minor changes to the Statutes

The COUNCIL begs leave to report to the University as follows:

1. This Report proposes amendments to the University's Statutes to correct or remove references that were overlooked when changes were originally presented for approval, and to make other minor changes.
2. Cross-references to the location of provisions concerning the membership of the Regent House in Statute A IV 2(e) and Statute B I 1 were not updated when those provisions transferred from Statute to Special Ordinance (*Reporter*, 6640, 2021–22, p. 171).
3. A reference to the Board of Graduate Studies in Statute A V 18 was not removed when the Board was disbanded (*Reporter*, 6570, 2019–20, p. 155).
4. The opportunity is also being taken to update the wording of Statute A X 9, replacing 'academic' with 'academic'.

5. **The Council recommends** that the Statutes of the University be amended as follows, and that these amendments be submitted to His Majesty in Council for approval.

(a) By amending Section 2(e) of Statute A IV (*Statutes and Ordinances*, p. 6) to read as follows:

- (e) four persons appointed by Grace of the Regent House who at the time of appointment are not qualified to be members of the Regent House except under Special Ordinance A (i) (a)(ii) nor are employees of the University or a College, one of whom shall be designated by the Council to chair the Audit Committee of the Council.

(b) By amending Section 18 of Statute A V (*Statutes and Ordinances*, p. 7) to read as follows:

**18.** There shall be Degree Committees for such Faculties and other institutions as may be determined by the General Board. Each Degree Committee shall be constituted in accordance with Regulations made by the General Board.

(c) By amending Section 9 of Statute A X (*Statutes and Ordinances*, p. 12) to read as follows:

**9.** Provision shall be made by Ordinance for the academic year, the dates of the Michaelmas, Lent, and Easter Terms in each academic year, for the dates of Full Term in each term, for residence, and for the Precincts of the University.

(d) By amending Section 1(e) of Statute B I (*Statutes and Ordinances*, p. 15) to read as follows:

- (e) a person falling within the terms of Special Ordinance A (i) (f);

## Report of the Council on a Visitor Welcome Building (Station Road gate) for the Botanic Garden

The COUNCIL begs leave to report to the University as follows:

1. The Botanic Garden is a Sub-department of the Department of Plant Sciences and is governed by a Syndicate which reports to the General Board. The primary functions of the Garden can be summarised as follows: the provision of facilities for teaching and research (undertaken by staff of the Garden and cognate Departments); the education of non-specialists from within the University and outside; the training of horticulturalists; and the provision of an amenity for the University and the City.

2. The Botanic Garden's existing Station Road gate entrance building (ticket kiosk) is contained within a small non-thermally insulated timber 'garden shed', which creates a poor first impression of the Garden and is inadequate for receiving visitors and supporting the associated administrative procedures. There are no welfare facilities for staff or storage space for guidebooks, maps and educational materials.

3. A proposal has been developed to demolish the existing entrance building and replace it with a visitor welcome building. This will be a single storey and energy efficient building, which will comprise a ticket office, commercial space, a small administrative office, three toilets (including a changing places toilet), a buggy store and an external bicycle parking area. Mechanical and electrical works will include new drainage and water supply, ventilation and heating with air source heat pump, electrical power supply and lighting, fire detection and

alarms and CCTV coverage. The Botanic Garden will undertake a landscaping scheme to complement the building.

4. The gross floor area will be 106m<sup>2</sup>. The current estimated cost of the project is £1,937k, of which at least £1,398k will be funded by the Botanic Garden from reserves and donations. The balance of the capital costs is expected to be met from the Planning and Resources Committee's Investment Fund, subject to receipt of a business case during Easter Term 2023.

5. Regent House approval is sought now so that the Estates Division can seek planning permission in May 2023. Subject to the approval of the recommendations of this Report, a decision on whether to proceed with the project will be taken by the Space Management and Minor Works Sub-Committee early in 2024, following further design development and the procurement of a main contractor. The works are expected to commence on site in late spring/early summer 2024. It is not expected to be necessary to close the Station Road gate entrance during the works.

### 7. The Council recommends:

I. That approval be given for the demolition of the existing entrance building and the construction of the proposed Botanic Garden Visitor Welcome Building (Station Road gate) as described in this Report.

II. That the Director of Estates be authorised to apply for Full Planning Permission in due course.

III. That the Director of Programme Delivery be authorised to accept a tender, within the available funding, for the proposed works in due course.

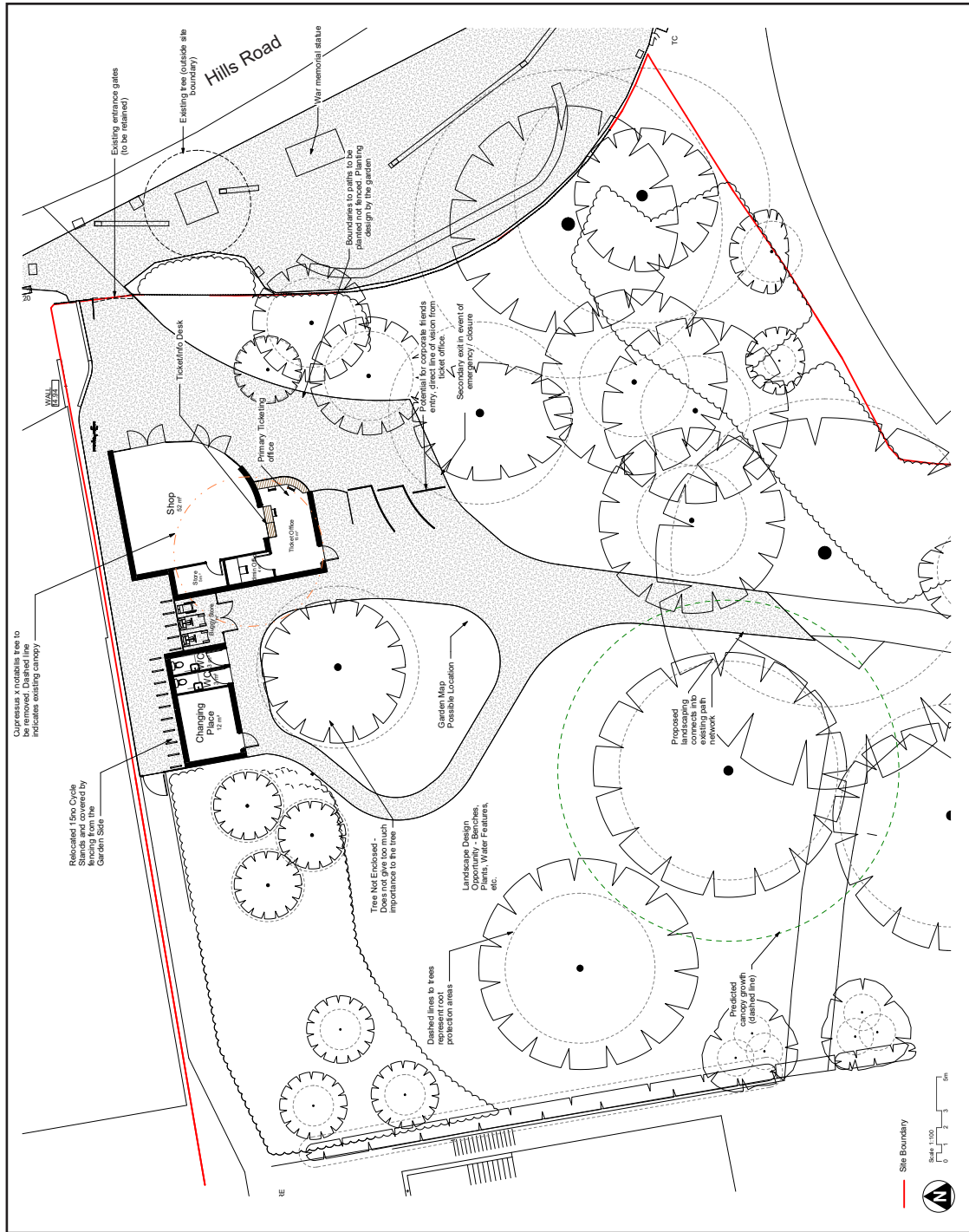
