**Notice of a benefaction**

*21 September 2023*

The Vice-Chancellor gives notice that she has accepted with gratitude a donation of £2.2m, payable over four years, from Mike Ashby, Emeritus Professor of Materials, to endow a University Associate Professorship or a University Assistant Professorship in Materials Science, which will be supported by the income from a Mike Ashby Fund. The Council is publishing a Grace (Grace 1, p. 15) to establish the Fund.

**Election and admission of the Proctors and address by the Vice-Chancellor on Monday, 2 October 2023**

The Vice-Chancellor gives notice that she will deliver an address to the University following the Congregation on Monday, 2 October 2023 for the election and admission of the Proctors (required by Statute C IV and the Special Ordinance made under it) and after swearing-in the University Constables under the Universities Act 1825. The election will begin at 10 a.m. Members of the Regent House and other members of the University community who wish to be present are therefore asked to be seated in the Senate-House **by 9.50 a.m.**; proceedings are expected to end before 11 a.m.

Matriculated members of the University community attending should wear academical dress (black gowns, hoods are not required). Tickets will not be issued and refreshments will be served afterwards.

**Correction to Notice in response to Discussion remarks**

*1 August 2023*<sup>1</sup>

In a Notice published on 26 July, the Council provided a reply to remarks on the General Board's response to the marking and assessment boycott, published on 22 June (*Reporter*, 2022–23; 6706, p. 773; 6710, p. 881). That reply on 26 July confirmed the specific limited criteria the Board had agreed to apply when making decisions about whether to exercise its discretion under Regulation 1 of the Ordinance for the Approval of Class-lists. Although the substance of the criteria was generally conveyed, the criteria themselves were not clearly set out as such in the Board's 22 June Notice, as the 26 July reply implied them to have been. It is regretted that this may have suggested that the question in the remarks was not a fair one.

## University of Cambridge Financial Regulations

14 August 2023

The Council, on the advice of the Finance Committee, has approved an amendment to the Financial Regulations. This amendment takes effect from 1 October 2023 and revises the Regulations reproduced in the *Statutes and Ordinances* (p. 1057).

The purpose of the Financial Regulations is to ensure the proper use of finances and resources in a manner which not only satisfies the requirements of internal control expected of a substantial and prominent organization, but also fulfils any legal or financial obligations as laid down by the Statutes and Ordinances of the University, HM Revenue and Customs, the Office for Students, and other authorities.

The amendment increases the current procurement threshold above which departments require three competitive quotes from £1,000 to £5,000. In *Schedule 1 – Competition Procedures* of the Regulations, the two references to £1,000 in the column for the Total Value (before VAT) have therefore been updated to refer to a threshold of £5,000.

Related changes have also been made to the Financial Procedure on expenses.

## Response to the marking and assessment boycott: Date for receipt of class-lists

31 August 2023<sup>1</sup>

The Regent House, by ballot in the Easter Term, approved an amended Grace in respect of dates for submission of class-lists (*Reporter*, 6700, 2022–23, p. 667). This Grace granted authority to allow the Registry, notwithstanding the Ordinances for the Dates of Examinations and for the Approval of Class-lists (*Statutes and Ordinances*, p. 254 and p. 258), to accept a list later than the day or time prescribed by Ordinance.

For Examinations for the Tripos and Preliminary Examinations for which class-lists were expected but not received in June 2023,<sup>2</sup> the General Board gives notice that the latest date on which the Registry may accept those class-lists shall be **Monday, 16 October 2023**. This is also the date by which the Board is asking for lists of those recommended for awards to be submitted by Degree Committees, and for the delivery of any remaining lists of approved marks and class-lists, for examinations with no prescribed deadline that were conducted in Easter Term 2023.

Boards of Examiners may seek permission exceptionally from the General Board, via [generalboard@admin.cam.ac.uk](mailto:generalboard@admin.cam.ac.uk), for the 16 October deadline to be extended. Such applications should explain the reasons for the delay, and indicate the date by which the class-lists will be submitted.

## Procedure for the Review of Decisions of University Bodies

8 September 2023

### With immediate effect

The General Board has agreed to amend the Schedule to its Procedure for the Review of Decisions of University Bodies (reproduced in *Statutes and Ordinances*, p. 224). The Procedure provides the University with a means to review decisions taken in relation to individual students by a number of different bodies and issue a Completion of Procedures letter, using a process that is in line with guidance issued by the Office of the Independent Adjudicator. The Schedule sets out the bodies whose decisions are included within the scope of the Procedure. The list of bodies has been updated to include the Fee Remission Panel, which has been set up by the Planning and Resources Committee's Fees and Funding Sub-Committee to consider applications from students for tuition fee remission. These applications were previously considered by the Examination Access and Mitigation Committee and the Postgraduate Committee.

## Reassignment of the Chong Hua Professorship of Chinese Development

21 September 2023

The General Board, on the recommendation of the Head of the Department of Politics and International Studies (POLIS), the Chair of the Faculty of Asian and Middle Eastern Studies (AMES), the Managers of the Fund supporting the Professorship, and Professor Hurst, the current holder of the Professorship, has agreed to propose the reassignment of the Chong Hua Professorship of Chinese Development from POLIS to AMES (*Statutes and Ordinances*, p. 741). Agreement has been reached on duties within POLIS that Professor Hurst will continue to undertake during a period of transition (including the supervision of his current Ph.D. students until completion) and on the income to be transferred from the Chong Hua Fund for Chinese Development to AMES to cover the stipend of the Professorship and to support Professor Hurst's research. The Managers of the Fund will not change. The QR income associated with the Professor will continue to be attributed to the School of the Humanities and Social Sciences. The Professorship will revert to POLIS when vacated.

The Council is submitting a Grace (Grace 4, p. 16) for the approval of this reassignment.

## Professorial Pay Review, 2022

This Notice gives information about the awards made following a review of professorial pay as at 1 October 2022, conducted in accordance with Annex 7 of the Second Joint Report of the Council and General Board on a New Pay and Grading Structure for Non-Clinical Staff (*Reporter*, 6002, 2004–05, p. 745) and Schedule 2 of the Joint Report of the Council and the General Board on amendments to the pay and grading scheme for non-clinical staff implemented following that Report (*Reporter*, 6302, 2012–13, p. 423). With the assistance of an Advisory Committee chaired by Professor Sir Nigel Thrift, the Acting Vice-Chancellor carried out an assessment of applications for a review of professorial pay received from eligible Professors. The Advisory Committee was assisted by School-level Committees which undertook the initial assessment of applications in Bands 1 and 2 (the membership of those Committees is noted below). Progression within and between bands is not automatic and is based on contribution, as described in Annex 7 of the Joint Report, and assessed through a biennial review process. The Vice-Chancellor will inform all applicants of the outcome of this review.

- ‘d’ indicates a subject in which a candidate may submit a dissertation in lieu of a final examination. The dissertation shall not exceed 18,000 words, including footnotes and appendices but excluding bibliography. It shall be on a topic approved by the Faculty Board falling within the field of the subject.
- ‘3’ indicates a subject in which a final examination is required (duration to be determined), the candidate having no option of substituting a dissertation.

The Council submits the following Graces to the Regent House. These Graces, unless they are withdrawn or a ballot is requested in accordance with the regulations for Graces of the Regent House (*Statutes and Ordinances*, p. 112), will be deemed to have been approved at 4 p.m. on Friday, 6 October 2023. Further information on requests for a ballot or the amendment of Graces is available to members of the Regent House on the Regent House Petitions site.<sup>§</sup>

1. That a Mike Ashby Fund be established in the University, to be governed by the following regulations.<sup>1</sup>

#### MIKE ASHBY FUND

1. The funds received from Professor Mike Ashby, together with such other sums as may be received or applied for the same purpose, shall form an endowment fund called the Mike Ashby Fund to advance research in the field of Materials Science by supporting a University Associate Professorship (Grade 10) or a University Associate Professorship (Grade 9) or a University Assistant Professorship, the office to be supported as determined by the Managers after having regard to the value of the Fund.

2. The Managers shall be responsible for the administration of the Fund and the application of its income and shall comprise the Head of the Department of Materials Science and Metallurgy, who shall be Chair, the Head of the School of the Physical Sciences and one member of the Department of Materials Science and Metallurgy appointed by the Head of the Department of Materials Science and Metallurgy for such period as the Head of Department shall determine.

3. Subject to Regulation 4, the income of the Fund shall be applied towards the payment of the stipend, national insurance, pension contributions, and associated indirect costs of the Mike Ashby University Associate Professorship (Grade 10) in Materials Science or other named academic office payable by the University.

4. Any unexpended income in any financial year, including income accrued during a vacancy in the academic office supported by the Fund may, at the discretion of the Managers:

- (a) be applied to support the work of the officeholder;
- (b) with the approval of the School Council, be applied to support research in the field of Materials Science in the University in such manner as may be recommended by the Managers; and/or
- (c) be carried forward for use as income in accordance with Regulation 3 in any one or more subsequent financial years.

2. That the Cambridge Committee for Russian and East European Studies (*Statutes and Ordinances*, p. 142) be retitled the Cambridge Committee for Central and East European and Eurasian Studies, all references to the Committee updated, and the reference to 'Russian and East European Studies' in Regulation 3(a) amended to refer to 'Central and East European and Eurasian Studies'.<sup>2</sup>

3. That, with effect from 1 July 2024, the Professorship of Law (1973) (*Statutes and Ordinances*, p. 712) be retitled the Professorship of International Dispute Resolution for a single tenure.<sup>3</sup>

4. That the Chong Hua Professorship of Chinese Development (*Statutes and Ordinances*, p. 741) be reassigned from the Department of Politics and International Studies to the Faculty of Asian and Middle Eastern Studies for the duration of Professor Hurst's tenure in the Professorship.<sup>4</sup>

5. That Regulations 2 and 4 of the Ordinance for the H. E. Woodman Fund and Prize (*Statutes and Ordinances*, p. 1045) be amended to read as follows:<sup>5</sup>

2. The Awarders of the Prize shall be the Regius Professor of Botany and the Arthur Balfour Professor of Genetics or their nominees. The Prize shall be awarded in the Lent Term each year to that person among the successful candidates for the degree of Ph.D. or M.Phil. who in the judgement of the Awarders has presented the best dissertation in plant genetics or biochemistry related to food and/or agriculture, bearing in mind the wishes of the donor that the Prize be awarded for distinction in a subject connected with the chemistry of foods.

4. The value of the Prize shall be such sum within a range approved from time to time by the Council as shall be determined by the Awarders. Any unexpended income in any financial year may, at the discretion of the General Board:<sup>[1]</sup>

(a) be carried forward for application in accordance with Regulation 2 in future years; and/or

(b) be applied to other purposes in support of postgraduate students whose research is in areas covered by the Prize.
