Chuan Lyu Fellowship and Senior Visiting Scholarship Fund

8 March 2024

Under section 67 of the Charities Act 2011¹, the Charity Commission has power to change the purposes of a charity after having regard to certain matters. The Commission has agreed to make a scheme to amend the Ordinance for the Chuan Lyu Fellowship and Senior Visiting Scholarship Fund (*Statutes and Ordinances*, p. 811). The current purposes of the Fund do not provide a use for all of its income. The effect of the scheme (available at <https://www.admin.cam.ac.uk/reporter/2023-24/weekly/6734/ChuanLyuFellowshipScheme.pdf>) is to widen the Fund's purposes so that, provided there are sufficient funds, the income of the Fund is not limited (as currently) to providing Research Fellowships and Senior Visiting Scholarships, but would additionally enable, at the discretion of the Managers, broader support of teaching and research in Taiwan Studies. The Council is submitting a Grace (Grace 3, p. 445) to amend Regulations 1 and 3 as well as the name of the Fund to reflect the changes being made by the scheme. The opportunity is also being taken to propose further minor amendments for approval by the University, which include changes to the composition of the Managers, and to allow for the appointment of more than one Research Fellow, Visiting Scholar or Researcher. The scheme is effective from 15 February 2024 and therefore the Grace, if approved, would take effect from that date.

NOTICES BY THE GENERAL BOARD**Establishment of a Professorship of Translational Auditory Neuroscience***8 March 2024*

The General Board, on recommendation of the School of Clinical Medicine, seeks approval for the establishment of a Professorship of Translational Auditory Neuroscience for a single tenure from 1 January 2025 in the Department of Clinical Neurosciences. The Resource Management Committee approved the supporting case for the Professorship at its meeting on 7 February 2024.

The salary costs of the Professorship will be met initially from the grants for two existing NIHR Biomedical Research Centre themes (Devices and Advanced Therapies) equating to 98% of the pay costs until November 2027. The remaining salary shortfall will be met from existing resources available to the Department of Clinical Neurosciences. Thereafter, the Professorship will be funded from the Van Geest Foundation Fund for Brain Repair and Neuroscience. The new Professor will be accommodated within existing facilities available to the Department in the Van Geest Building with dedicated laboratory space. The University is establishing itself as one of the top UK institutions for auditory implant research. This Professorship is one of two leadership positions in this area, the other being the existing Professorship of Otolaryngology and Skull Base Surgery. The proposed office is critical as a complementary appointment. The most successful auditory research centres worldwide all have complementary surgical and auditory research leadership roles. The Professor of Translational Auditory Neurosciences is a strategic role providing vision and leadership in the translation of medical devices and advanced therapy research. This is key to furthering the otology and audiology research aims in the hearing and vision theme in the Department and building the experimental and advanced therapies cluster.

The General Board, on the recommendation of the Council of the School of Clinical Medicine, has agreed that election to the Professorship shall be made by an *ad hoc* Board of Electors and the electors should give preference to those candidates working within the field of translational auditory neuroscience for hearing device users and medical device translation.

The Council is submitting a Grace (Grace 1, p. 444) for the establishment of the Professorship.

Dissolution of the Examination and Assessment Committee*With immediate effect*

The General Board's Education Committee has approved the dissolution of the Examination and Assessment Committee. The Examination and Assessment Committee was established in 2019 as a sub-committee of the Education Committee after the review of examination processes in 2017, which resulted in the dissolution of the Board of Examinations (see the Report: *Reporter*, 6509, 2017–18, p. 672). The core purpose of the Committee, to promote diversification of assessment across the University, has been achieved. Other initiatives, including those relating to digital assessment, have been absorbed by newer bodies that were set up by the Education Committee during the Covid-19 pandemic to facilitate remote teaching and assessment. Responsibility for University assessment practices remains with the Education Committee.

The General Board has approved the following revised delegations recorded in Notices and procedures published by the General Board and reproduced in Statutes and Ordinances, and in footnotes attached to General Board Regulations.

Rules for the Guidance of Candidates and for the Prevention of Misconduct in Examinations (*Statutes and Ordinances*, p. 206):

By replacing the words 'appointed by the Examination and Assessment Committee' with 'appointed by the General Board' in paragraph 3.7.

Procedure to Support and Assess Capability to Study (*Statutes and Ordinances*, p. 242):

By replacing the words 'the Examination and Assessment Committee' with 'the General Board's Education Committee' in the footnote attached to paragraph 4.1(d).

General Regulations for Preliminary Examinations (*Statutes and Ordinances*, p. 263):

By removing the footnote attached to Regulation 2.

Natural Sciences Tripos, Part II (*Statutes and Ordinances*, p. 417):

By removing the reference to the Examination and Assessment Committee in the footnote attached to Regulation 30 in relation to the subject Biological and Biomedical Sciences.

General Regulations for the degree of Master of Research (*Statutes and Ordinances*, p. 541):

REGULATIONS FOR EXAMINATIONS

Mathematical Tripos, Part III, and Mathematics for the M.A.St. Degree

With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Mathematics, has approved the amendment of the regulations for the Mathematical Tripos and the course in Mathematics for the degree of Master of Advanced Study so as to reduce the amount of non-essay units of assessment.

MATHEMATICAL TRIPOS, PART III

(*Statutes and Ordinances*, p. 389)

Regulation 15.

By removing the word ‘optional’ from the first sentence of Regulation 15.

Regulations 16–18.

By replacing the text of Regulations 16, 17 and 18 with the following:

16. Before the last day of the Full Michaelmas Term next preceding the examination the Examiners shall announce a number of topics for an essay. A candidate may request permission to submit an essay on a topic other than those announced, provided that the request is made, through the candidate’s Director of Studies, so as to reach the Secretary of the Faculty Board not later than 1 February next preceding the examination. Any additional topics approved by the Examiners shall be announced by them not later than 1 March next preceding the examination.

17. A candidate may submit an essay on a topic that has been announced under Regulation 16, in accordance with instructions that shall be announced by the Chair of the Faculty of Mathematics, or their duly appointed Deputy, not later than the division of the Michaelmas Term next preceding the examination. At the discretion of the Examiners the examination may include an oral examination on the candidate’s essay.

18. Each candidate shall submit a form, countersigned by their Director of Studies, to the Chair of Examiners, so as to arrive not later than 12 noon of the second Thursday of the Full Easter Term in which the examination is to be held, listing the titles of the papers that they wish to offer, and the title of their essay. No candidate shall offer written papers whose total duration amounts to more than sixteen hours, and each candidate may offer one essay in accordance with the provisions of Regulations 16 and 17.

MATHEMATICS FOR THE DEGREE OF MASTER OF ADVANCED STUDY

(*Statutes and Ordinances*, p. 446)

By removing the word ‘optional’ from the first sentence of the special regulations for Mathematics.

Bachelor of Medicine and Bachelor of Surgery

(*Statutes and Ordinances*, p. 470)

With effect from 8 November 2023

The General Board, on the recommendation of the Faculty Board of Clinical Medicine, has approved the amendment of the Curriculum Regulations for the degrees of Bachelor of Medicine and Bachelor of Surgery to ensure that course progression regulations are appropriately maintained when the new Medical Licensing Assessment (MLA) is implemented, and to be consistent with General Board’s decision to allow University affiliation to be granted to clinical placement providers, as follows:

Regulation 3(f).

By revising Regulation 3(f) to read as follows:

(f) the term *approved assessments and courses of clinical instruction* shall mean: courses or placements which are held in the University, University Hospital, Teaching Hospital Partner, Affiliated Teaching Hospital, or Affiliated Teaching General Practice, or other institution associated with the University as the Faculty Board may approve for the purpose of these regulations, and which have been approved by the Faculty Board as courses appropriate to a Part of the Final M.B. Examination; assessments which may take various forms, and may take place as part of a placement or may be set by an external body such as the General Medical Council or UK Foundation Programme, and which have been approved by the Faculty Board as appropriate to a Part of the Final M.B. Examination.

Regulations 15, 18 and 19.

By revising the text of Regulations 15, 18 and 19 to read as follows:

15. The number of components for examination shall be determined by the Faculty of Clinical Medicine, and a list of the components, as well as a timetable for each sitting of the examinations, shall be published in the Michaelmas Term. Except by permission of the Faculty Board under exceptional circumstances, in any calendar year, there shall be no more than two sittings of Part I, Part II and the written components of Part III, and no more than one sitting of the clinical components of Part III. The examinations shall normally be held in accordance with the following timetable.

Part I shall be held in June or July and Part II shall be held in the Easter Term. The written component(s) of Part III shall be held in December or January, and the clinical component(s) of Part III shall be held in the Easter Term.

Part I and Part II shall also be held in September or October; the written components of Part III shall also be held in the Lent Term.

Candidates for Part III shall also be required to undertake the Prescribing Safety Assessment, which shall be held in the Lent and Easter Terms. They shall also be required to undertake a clinical apprenticeship, which shall take place following Part III clinical component examinations. Except by special permission of the Faculty Board in exceptional circumstances, students must pass the Prescribing Safety Assessment and must satisfactorily complete the clinical apprenticeship before the degrees of Bachelor of Medicine and Bachelor of Surgery can be awarded.

18. Except by permission of the Faculty Board under exceptional circumstances, and subject to any conditions determined by the Board

- (a) a student who proposes to be a candidate for any Part of the Final M.B. Examination shall produce evidence of having satisfactorily completed the approved assessments and courses of clinical instruction appropriate to that Part;
- (b) with the exception of Cambridge Graduate Course students, a student's course of clinical instruction shall not count towards the requirements of the Final M.B. Examination if it began before the student's completion of the Second M.B. Examination, or if it began before the student obtained the degree required under Regulation 17 above .

19. Except by permission of the Faculty Board under exceptional circumstances, and subject to any conditions determined by the Board

- (a) a student who has failed to complete satisfactorily any part of the approved assessments and courses of clinical instruction, including permitted reassessments as specified by the Faculty Board of Clinical Medicine, shall not be permitted to progress to the next course of clinical instruction or assessment.
- (b) a Cambridge Graduate Course student who has not successfully completed the Second M.B. Examination shall not be permitted to be a candidate for Part II of the Final M.B. Examination.

Regulation 20.

By adding an initial sentence to Regulation 20 and amending the text of sub-paragraph (a) as follows:

20. Except by permission of the Faculty Board under exceptional circumstances, and subject to any conditions determined by the Board

- (a) A student who is a candidate for the first time for Part I, Part II, or Part III shall offer all components.

Strategy, Marketing and Operations for the M.Phil. Degree

(*Statutes and Ordinances*, p. 539)

With effect from 1 September 2025

The General Board, on the recommendation of the Degree Committee for the Faculty of Business and Management, has approved a change to the title of the examination for the degree of Master of Philosophy by Advanced Study in Strategy, Marketing and Operations to *Strategy, Marketing, Operations and Organisational Behaviour* to more clearly represent all taught areas of the course. The title of the special regulations and text of Regulation 1 will be updated accordingly.

Theology, Religion and Philosophy of Religion for the M.Phil. Degree

(*Statutes and Ordinances*, p. 539)

With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Divinity, has approved amendments to the special regulations for the examination in Theology, Religion and Philosophy of Religion for the degree of Master of Philosophy by Advanced Study to amend the scheme of examination as follows:

Regulation 1(a).

By amending the text of Regulation 1(a) to read as follows:

- (a) a dissertation of not more than 15,000 words in length on a subject approved by the Degree Committee for the Faculty of Divinity; *and*

Regulations 2 and 3.

By amending the text of Regulations 2 and 3 to read as follows:

2. A candidate's choice of written work shall be made with the approval of the Degree Committee and in the light of the prerequisites for a dissertation in their chosen subject area and of the coherence of the candidate's programme, by the end of the Michaelmas Term for a candidate on the one-year full-time course, and by the end of the Michaelmas Term of the first year for a candidate on the two-year part-time course.

3. The subject areas available for examination and the arrangements for the submission of the written work shall be announced by the Degree Committee no later than the end of the Easter Term of the academic year preceding that in which the examination is to be held.

Crime and Thriller Writing for the M.St. Degree

(*Statutes and Ordinances*, p. 556)

With effect from 1 October 2024

The General Board, on the recommendation of the Strategic Committee of the Institute for Continuing Education, has approved the withdrawal of the course of study in *Crime and Thriller Writing* for the degree of Master of Studies from 1 October 2024.

Diploma in Theology for Ministry

(*Statutes and Ordinances*, p. 594)

With effect from 1 October 2024

The General Board, on the recommendation of the Faculty Board of Divinity, has approved an amendment to the regulations for the Diploma in Theology for Ministry to amend the scheme of examination as follows:

Regulation 3(c).

By amending the text of Regulation 3(c) to read as follows:

- (c) a dissertation, which shall count as one full paper, on any topic approved by the Faculty Board, in accordance with the arrangements published by the Faculty Board under Regulation 17 for the B.Th. Degree.

The Council submits the following Graces to the Regent House. These Graces, unless they are withdrawn or a ballot is requested in accordance with the regulations for Graces of the Regent House (*Statutes and Ordinances*, p. 112), will be deemed to have been approved at **4 p.m. on Friday, 22 March 2024**. Further information on requests for a ballot or the amendment of Graces is available to members of the Regent House on the Regent House Petitions site.[§]

1. That, on the recommendation of the General Board, a Professorship of Translational Auditory Neuroscience be established for a single tenure from 1 January 2025, placed in the Schedule to Special Ordinance C (vii) 1 (*Statutes and Ordinances*, p. 86), and assigned to the Department of Clinical Neurosciences.¹
2. That the Ordinance for Endowed University Lectureships (*Statutes and Ordinances*, p. 767) be retitled the Ordinance for Benefactions Endowing University Teaching, the first clause of Regulation 1 amended to read as follows, and the following new entry added to Regulation 1:²

[1.] Benefactions received by the University for the endowment of University teaching shall be applied to the payment of the stipends of University Associate Professors (Grade 10), University Associate Professors (Grade 9), University Assistant Professors and University Lecturers in connection with the several Faculties as follows:

3. That with effect from 15 February 2024, Regulations 1 and 3 of the Ordinance for the Chuan Lyu Fellowship and Senior Visiting Scholarship Fund and the name of the Fund (*Statutes and Ordinances*, p. 811) be amended to reflect the wording of a scheme made by the Charity Commission, to read as follows:³

CHUAN LYU FUND FOR TAIWAN STUDIES

1. The sum received by the University from the Chuan Lyu Foundation shall form a fund, called the Chuan Lyu Fund for Taiwan Studies, the income of which shall be used to support teaching and research in Taiwan Studies.

2. The Managers of the Fund shall be four persons appointed by the Head of the Department of East Asian Studies in consultation with and with the agreement of the teaching officers in Chinese in the Department, one of whom shall be a Professor in the field of Chinese Studies. The Managers shall be appointed in the Michaelmas Term to serve for three years and may be reappointed.

3. The income of the Fund shall be applied at the discretion of the Managers towards any or all of the following:

- (a) to provide the stipend, national insurance, and pension contributions of one or more Chuan Lyu Research Fellows who shall engage in teaching and research in the field of Taiwan Studies;
- (b) to provide the subsistence allowance and travel costs of a Chuan Lyu Senior Visiting Scholar who shall offer lectures and engage in research in their area of expertise within the field of Taiwan Studies;
- (c) to provide the subsistence allowance and travel costs of one or more Chuan Lyu Researchers who shall offer lectures and engage in research in their area of expertise within the field of Taiwan Studies;
- (d) to facilitate access to Taiwanese institutions and resources and promote scholarly exchange between scholars in Taiwan Studies at the University and other institutions;
- (e) to fund library resources in support of the study of Taiwan.

4. The Managers of the Fund shall be responsible for selecting any Chuan Lyu Research Fellow, Senior Visiting Scholar or Researcher, taking account of the candidates' written research proposals.

5. The Managers of the Fund shall have power to determine from time to time the period of tenure of any Chuan Lyu Research Fellowship and the stipend to be attached to each period of tenure, within a range approved from time to time by the General Board. In considering any extension to a Fellow's original tenure, the Managers shall take account of progress made in the light of the original research proposal.

6. The Managers of the Fund may terminate a Fellowship at any time if they are not satisfied that the Fellow is diligently fulfilling their duties.

7. The Managers of the Fund shall have power to determine from time to time the period of invitation of a Chuan Lyu Senior Visiting Scholar or Researcher and the level of subsistence allowance to be offered.

8. Any unexpended income of the Fund in a financial year may be added either to the capital of the Fund or accumulated for use as income in subsequent years as the Managers may determine in support of the purposes of the Fund as set out in Regulation 1.
